 - a. Community Litter Program Report September.
 - Litter program coordinator cleaned up 9 illegal dumpsites removing 3,020 pounds of garbage, 12 tires, 1 television, and 1 refrigerator.
 - The contracted roadside litter crew spent 64 hours cleaning 48.5 miles removing 2,760 pounds of litter.
 - Volunteers in Centralia and throughout Lewis County spent 76.75 hours removing 95 bags of litter.
