- III. Approve the minutes of the June 26, 2023, regular meeting.Motion by Lindsey R. Pollock, DVM, and seconded by Scott J. Brummer. Motion carried.

- VII. Transfer Station Operations Presented by Rocky Lyon, Solid Waste Manager.
 - a. Community Litter Program Report June.
 - Litter program coordinator and crew cleaned up 36 road miles, spent a total of 112.5 hours picking up 1100 pounds of litter. They spent a total of 33 hours cleaning up 5 illegal dumpsites, removing 920 pounds of garbage.
 - Volunteers in Centralia and throughout Lewis County reported spending 204.75 hours collecting 207 bags of litter.
 - b. Transfer Station Tonnage June.
 - Combined monthly tonnage was 8,194.
 - Year to Date tonnage was 44,011.
 - c. Recycling update.
 - Cart Tag and Lid Lift Audit was completed. They reached all 20,000 customers. Due to the audit, contamination was reduced by 18.75 percent. Multi-family recycling was implemented in 256 apartment units.
 - Community Litter Coordinated Prevention (CLCP) and Local Solid Waste Financial Assistance Program (LSWFA) grants were awarded. With the litter grant we can purchase a litter vacuum for our litter truck.
- VIII. Financial Reports Presented by Rocky Lyon, Solid Waste Manager.
 - a. Monthly reports June.
 - Fund 415 revenue per the Munis report was \$959,823 and showed a net operating gain of \$90,562. The ending fund balance was \$4,350,426.
 - Fund 401 total expenses \$335,028.
 - Total reserve balances \$1,035,497.

 - Rocky went to a conference where he inquired about what other facilities do with RV's. Other facilities tend to
 refer them to a junk yard as they are not equipped to deal with full tanks and disposing of liquids from the RV's.
 Plans could potentially include creating a facility that would be able to handle all it takes to properly dispose of
 RV's.
 - b. Staffing.
 - New operator has been hired and will start August 1, 2023.
 - Scale Attendant position has been posted and we have many applicants.
 - Office Assistant position is still vacant.
